

Instructions	A painter will choose an opaque or transparent colour, according to the effect they desire. For example, a glaze requires a transparent colour, while a solid, an opaque colour. To achieve a watercolour-like render, the painter will select a transparent colour. The versatility of the range means that it can be used with an endless amount of textures.
Core Drying	Away from dust, in 30 minutes to 1 hour. In 1-8 days depending on the thickness
Dilution	Thinner: Water, but this results in a loss of consistency, or Bindex Brilliant Binder Studio Acrylics.
Cleaning	Cleaning the tools : With water before drying
Application Supports	Canvas, cardboard, wood, metal...
Projects Protection	When the colour is applied thickly, it is advisable to wait 1 to 2 weeks before varnishing the work.
